istorically across Ohio, much of the long-range transportation planning focused on metropolitan areas. In recent years, the Ohio Department of Transportation (ODOT) recognized the need for similar planning efforts in rural regions of the state. The most recent federal transportation bills likewise helped drive this philosophy, potentially making the access to federal highway funds contingent upon proper planning.

A pilot program was initiated and funded in 2013 by ODOT to help five Ohio regions, covering 34 non-metropolitan counties across the state, with their transportation planning.

A primary goal was to encourage comprehensive and informed transpor-

tation decision-making across all of Ohio, not just in our urban areas.

This momentum led to the beginnings of a similar formation of a Rural Transportation Planning Organization in Central Ohio. Mid-Ohio Regional Planning Commission (MORPC), the planning organization for the Columbus urban area, was designated as the mentor for the seven-county plan. The Central Ohio Rural Planning Organization (CORPO) [by now you have probably noticed that planning requires heavy use of acronyms!], was formed partnering Union County with Fairfield, Knox, Madison, Marion, Morrow, and Pickaway Counties.



With assistance from MORPC, each individual county was responsible for leading their transportation planning process. I chaired our local subcommittee, which was made up of staff members from Marysville, Dublin, the Ohio Department of Transportation, other Union County public agencies, and industry representatives.

We worked through our existing transportation conditions, future growth projections and goals, and ultimately prioritized our area's future projects.

MORPC's final report text and our final list of 30 key projects generated by City and County engineering staff was recently approved. While such a planning effort is time consuming, it generated several key takeaways:

- The list of projects, ranging from 2 to 30+ years out, have a total price tag of almost \$500 million!
- This staggering cost is an example of the transportation challenges our nation has ahead of it—the list is made up of our county's high-profile projects and doesn't include the typical annual work like road resurfacing and bridge replacements/repairs.
- Many of the projects involve multiple agency and funding partners—an important point—as the traveling public doesn't care who is responsi-

ble for the road they are using, they just need it to function safely and efficiently.

Getting many of these projects across the finish line in the future will take successful partnerships and plenty of cash. Hopefully our CORPO efforts can be a useful tool to help foster that cooperation and to develop funding strategies.

# Reminder as Roadside Mowing Continues

They may not be placed within county road right-of-way. The only exception would be for properties with yard sections along roads where the property owner mows and maintains the right-of-way.

We will remove all signs not complying with our policy and store them at

either our Marysville Operations Facility or our Richwood Operations Facility until November 15, 2018. We will dispose of them after that date.

slated to become effective on January 1, 2019. It is based on the 2018 International Building Code (IRC) and replaces the 2013 RCO. The State of Ohio is currently in the process of modifying the 2018 IRC with state specific language. More details

#### **New Residential Inspections for 2018**

Union County added two mandatory inspections starting January 1st: shear wall inspection and finish grade inspection. The shear wall inspection

ensures the proper installation of the lateral bracing system of a structure. All structures are required by building code to be braced to resist the lateral loads due to wind and seismic activity. Wall construction must include bracing to resist the imposed lateral loads resulting from wind or seismic loading and provide stability to the structure. The proper installation of the lateral bracing system

minimizes property damage due to weather (and other events) and maintains the structural integrity of structures.

The finish grade inspection ensures both the proper water drainage from structures and the

proper elevation (height) of buildings relative to finish grade. A top of foundation wall certificate is required for new residences only to guarantee

it is installed at the proper grade elevation. Lots are required to drain surface water away from foundation walls. The finish grade shall fall a minimum of six inches within the first ten feet. In certain circumstances, drains or swales are permitted to be installed in lieu of providing this minimum slope. Proper site drainage is an important element in preventing wet basements, damp

crawl spaces, eroded banks, and foundation wall failures. Proper building placement is an important element in preventing excessive driveway slopes and water drainage onto adjacent properties while aiding adequate onsite water drainage.




**Proper Elevation** 

### 2018 Record Breaking Number of Single Family Home Permits Projected

This chart depicts the total number of single family home permits issued each year, beginning in 2007.

Based upon the number of single family permits issued from January-May of 2018 (223) we project a total of nearly 550 new home starts by the end of December. We may even beat our record of 577 single family home permits issued in 2003.

Jerome Township and Marysville have seen the most growth.

### **Advances in Transportation**

### **Union County Heads West to Discuss Hyperloop**

In May, representatives from the Union County Engineer's Office and Union County Chamber of Commerce joined other regional government officials and agencies in a trip to California and Nevada to learn more about the potential for a high-speed transportation corridor in the area. The Mid-Ohio Regional Planning

Commission (MORPC) led a contingent to visit the Virgin Hyperloop One headquarters in Los Angeles to further discuss the technology that can propel travel pods of freight and/or cargo inside of a vacuum tube suspended



via magnetic levitation at speeds up to 700 mph. Even though this sounds like a technology more suited for the Jetson's than something you would see currently, the group then traveled to Las Vegas to Hyperloop's one-of-a-kind proving ground, dubbed DevLoop, where they have actually already successfully tested the technology via a 500 meter full scale test track.

The Midwest Connect route, if realized, could connect Pittsburgh, Columbus and Chicago with this new form of transportation, resulting in travel times from Columbus to either city in less than 30 minutes. This route was one of only 10 in the entire world chosen by Virgin

Hyperloop One for further analysis among over 2,600 applicants as part of their Virgin Hyperloop One Global Challenge. Communities along the proposed route could potentially construct "stations" to access the infrastructure, similar to a freeway interchange ramp.

MORPC has recently announced that they are moving forward with studies to further look at the feasibility and environmental considerations for high speed travel between the three cities. This is part of MORPC's Rapid-Speed Transportation Initiative, which will also look at the option of high speed passenger rail along the same route. The studies are anticipated to be completed by July 2019.

# 2018 Parade of Homes Returns to Jerome Village

Later this summer, The Building Industry Association of Central Ohio (BIA) will host their yearly showcase of Central Ohio's top homebuilders within the Jerome Village Master Development in Jerome Township. The Parade of Homes will run from Saturday, September Ist through Sunday September 16th, and will be located in the Eversole Run Neighborhood near the southwest corner of Hyland-Croy Road and Ravenhill Parkway.

## Jerome Grand at Jaquemin Farms Breaks Ground

Construction began in mid-May on a new mixed-use development in Jerome Township. Jerome Grand at Jacquemin Farms consists of a 300 unit residential rental community, an assisted living facility and planned retail development.

Schottenstein Real Estate group is the developer of the site, which is located on the west side of Hyland-Croy Road, just north of the Post Road intersection. In order to help migitage the increase in traffic, a northbound left turn lane and a traffic signal will be installed at the intersection of Park Mill Drive. Rental community units are planned to be available by 2019.

#### **Work Performed by County Forces**

#### Culverts Replaced



County crews will perform over 20 culvert replacements this year as well as replace seven small bridges. Pictured above is a culvert installation on Delaware County Line Road. Culvert work is typically completed in one to two days, while small bridges may take up to four weeks to finish.

#### Roadside Mowing



Roadside mowing started in early May and will continue through October. Our Union County crew mows up to six rounds of 1,040 miles of county and township road-sides each year requiring over 4,000 man and equipment hours. Tyler Griffith, Roy Hammond, and Rick Kingham make up this year's mowing crew.

## Tree Removal/Right of Way Work Performed

In 2017, county forces spent 2,500 hours performing tree and brush removal along county and township roads to help improve sight distance and provide safer intersections. Our program will continue in 2018 with over \$75,000 budgeted for this work.

#### **Pavement Patching**



County workers place asphalt patches on select county and town-

ship roads each year prior to chip seal. They use a grader, tandem roller, and dump trucks to patch distressed areas on our roads. Approximately 1,700 tons of asphalt are expected to be used this season.



County workers also perform partial depth pavement repairs on higher volume priority roads. A milling machine is used to grind out damaged areas of pavement to a depth of up to three inches and then a widening box is used to place new asphalt in those sections. This process is used to repair badly rutted pavement or areas where the pavement is breaking up. It leaves a rectangular looking area in the pavement when completed.

#### **Work Performed By Contract**

#### Phelps Road Bridge Improvement Begins

This summer another steel truss bridge will be retired and a new concrete structure erected on Phelps Road over Bokes Creek in York Township. A contract of approximately \$690,000 was awarded to **R & I Construction**, **Inc.** from Tiffin, Ohio. Funding for this new bridge includes 5% from our share of the sales tax revenue and 95% federal highway funds.

This old steel truss bridge built in the 1920's, has become structurally deficient with a 20-ton load limit that provides only one lane of traffic. The new structure will be able to carry all traffic loads and will support two lanes. The three-month project is expected to be completed by mid-September.



#### **Scottslawn Road Improvement Planned**

Planning and design continue for road widening work along Scottslawn Road. Most of the construction is slated for 2019, with utility relocation and some potential grading work taking place later this year.

The I.5 mile improvement, between SR736 and the Heritage Cooperative Ag Campus, will involve the reconstruction of roadside ditches, wider shoulders and pavement widening. New turn lanes will be built at the Heritage entrance

to accommodate truck traffic, and a right-turn lane will be added at Weaver Road. Scottslawn will remain a two-lane roadway, but the paved berms will greatly enhance safety for the increasing traffic.

The estimated project cost will total around \$2.4 million. Around 40% of that price tag will be covered by an Ohio Public Works Commission grant that we secured late last year.

#### Resurfacing Project Slated to Begin in August

Bids were recently received for this year's paving program. Six miles of roadway will be resurfaced at a cost of a little over \$800,000 funded in part by our portion of the 1/4% sales tax revenue. The roads slated to be resurfaced include Brock Road and portions of Mitchell-Dewitt and Hyland Croy Roads. Northwest Parkway is scheduled to be improved by contract in July or August by a process called micro-surfacing.

#### **Chip Sealing Program Underway**

Our crews started work on our annual sealing program in early July. This summer's chip seal resurfacing involves 99 miles [34 township —65 county] of roadway in the southern portion of the county. A complete list of the roads can be viewed on our website (co.union.oh.us/news), and the schedule is updated weekly.

We make every effort to minimize inconveniences as we perform our summer sealing program, however loose stone and excess tar are always a possibility on newly treated roadways. Slowing down on freshly sealed roads is a good idea for two reasons; issues with loose stone are minimized, and asphalt is less likely to end up on vehicles.

Local traffic will be maintained during the operation, but motorists may encounter slight delays. As always, when approaching the flaggers and equipment, please slow down to guarantee the safety of both our crews and other drivers.

The sealing program is our largest annual in-house construction expenditure. This year's work will total nearly \$1.0 million in liquid asphalt and stone. At an average total cost of \$12,000 per mile, it is an important tool to help stretch our road maintenance dollars. By comparison, a mile of new blacktop placed by contract will cost around \$125,000.
